- Abandoned Cars:

 - HOA will place a tag on abandoned vehicles with a 7-day notice to move before towing.
 - HOA will work with the board member at large to coordinate towing
 - HOA needs 5 pictures of the vehicle to follow protocol
- Stair/deck Painting:
 - Peeling paint at buildings 1145 and 1137.
 - Please send HOA Services pictures and Vivax will be contacted to repaint.
 - It was noted that Vivax provides a warranty on their work
- Holiday Lights:
 - Rebekah is working on holiday light issues.
 - White Christmas lights are not acceptable as decorative lights.
 - Any questionable lights will be forwarded to the board for review.
- Coolers:
 - Coolers will be turned on early, weather permitting, aiming for the beginning of May.
- Decks:
 - Three decks completed this spring with Vivax, expected mid-June.
 - Will continue to update owners as we have more information

Budget
